- Lindsay Cutler and Kylee Christianson commented on the upcoming Dollars for Scholars Auction to be held on October 18, 2025; Superintendent Parkhurst announced that this is Homecoming Week with a variety of activities and it is also Open House week for the two elementary schools; NSS on Wednesday and SES on Thursday. Mr. Parkhurst also shared that a new Student BOE representative will be joining us at an upcoming meeting.

- Mr. Stacy and Dr. Bissonnette reviewed the above policies and the Board will review these and revisit them for a second read at the October 9, 2025 BOE meeting. These are also posted on our website as policies under review. Motion was made by Alba Osorio; to rescind 5131.911 and seconded by Lindsay Cutler; passed unanimously.

## Special Education Report

- Superintendent Parkhurst explained that a new requirement is to annually provide the BOE with a Special Education Annual Report by September 30th of each year. The report was shared with the Board and Mr. Josh Robinson provided the Board with some highlights of what to look for as they read the report. Superintendent Parkhurst shared that he would like the Board to take the time to read this report and then the Special Education Administrators will be present at the next meeting to answer any questions that the Board may have.

## II. Old Business

### A. WLHS Track and Football Field Status

- Superintendent Parkhurst shared that earlier this evening he learned that the district was awarded a \$250,000 Planning Grant from the Community Investment Fund to further refine the planning and development of the project to be ready for the new round of grant funding. Mr. Parkhurst will work with KBA and the First Selectman to further refine this based on the grant.

### B. Pay to Participate

- Superintendent Parkhurst shared that to date a total of \$14,439.98 has been collected; to date no transportation bills have been received yet. There are 15 students with outstanding bills at WLHS and 2 at WLMS. A total of 26 waivers were submitted with 22 being granted.

### C. Strategic Planning Process

- Superintendent Parkhurst shared that the three work teams are well underway; the work teams are **Student Performance, Climate & Culture, and Facilities and Operations**. The Facilitators of each work team meet with the Superintendent monthly. In addition, Mr. Parkhurst and Dr. Bissonnette have prepared a slide deck for each respective administrator to review the process and steps with their staff at their October faculty meeting. Superintendent Parkhurst further shared that although the strategic plan will be a 5 year plan, each building will create from the 5 year plan a yearly school improvement plan that will be developed by the building based team through facilitation of the building administrator(s) in alignment with the District Strategic Plan.
